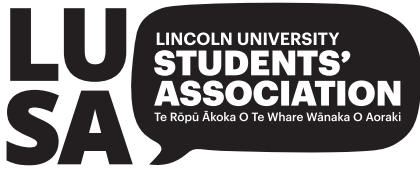

Summary of Rules for LUSA Executive Elections

For detailed information please refer to Schedule B of the LUSA Constitution.

Requirements for Candidacy

Nominations shall be deemed valid by the Returning Officer provided:

- (a) Current Student: That the prospective candidate is a student. In the case of a returning President this sub-clause shall not apply.
- (b) President: In the case of the President the prospective candidate:
 - (i) has not been elected for two (2) or more consecutive terms;
 - (ii) should have been a student for at least one (1) year before they were elected, as generally this will ensure the successful candidate will have relevant knowledge, skills, or experience to serve as a Lincoln University Council appointee. In the case of a returning President, this sub-clause does not apply.
 - (iii) must not be disqualified from membership of Council by virtue of section s277 of the Education and Training Act 2020.
- (c) Postgraduate Representatives: The prospective candidate shall currently be enrolled and/or applied for Postgraduate Study at Lincoln University.
- (d) International Representative: The prospective candidate shall be enrolled as an international student as defined by Lincoln University
- (e) Rainbow EDI Representative: The prospective candidate shall be part of the Rainbow community or an ally
- (f) Disability EDI Representative: The Prospective candidate must have a disability as defined by the National Disabled Students' Association. As stated above, the candidate does not need to disclose their disability with students, however, will need to disclose to the returning officer and if necessary, the President.
- (g) Pasifika Representative: The prospective candidate must be from the Pacific Islands or have Pacific Island heritage.
- (h) Endorsement: At least three other Lincoln University students endorse the nomination on the official Association Nomination Form.
- (i) Qualified: That the prospective candidate is qualified, as defined within the LUSA Constitution.
- (j) Nominations: The candidate can stand for up to a maximum of two positions.

Photo, Biographical Note and Policy Statement

Candidates must supply a current and reasonable quality photo of themselves alongside a biographical notes and policy statement (blurb) when they submit their nomination form.

The length of the blurb is dependent on the position you are nominated for. If a candidate applies for two positions, then they can write two separate biographical notes. The maximum length of the blurbs are: President-500 Words; Vice-President-400 Words; and all other positions-300 words.

If a candidate fails to supply any of the above by the deadline they will not be disqualified from the election, but LUSA will only include their name in all promotional material.

Advertising and Promotional Materials

The campaigning period is 12.01am on Monday 14th September to 11.59pm to Sunday 27th September 2026. All material must be taken down by 11.59pm, Sunday 27th September 2026. Any candidate who does not abide by this may be disqualified from the election if the Returning Officer identifies a breach of regulations.

You can promote yourself however you like provided it does not damage anything, harm anyone or otherwise bring yourself, the University or LUSA into disrepute.

There must not be any public speaking on campus or promotional material, either online or on-campus, on the days that voting takes place.

Voting

All Lincoln University Students will be emailed a link to the online voting platform on the morning of Monday 28th September 2026. Voting will open at 9.00am on this day. Voting will close at 11.59pm on Monday 5th October 2026. Results will be announced to the candidates first, and then the student body.

Good Faith

All candidates are expected to act in good faith and abide by the regulations set out in the Elections Policy AND Elections Procedure, as well as the Constitution. If you experience any harassment or discrimination during campaigning or if you need general wellbeing support at any time during the election process, there are number of services available on campus.
